To whom this may concern

I am getting in touch with a complaint against the legal entity **HS and Partners** located in Mississauga Ontario, and specifically the lawyer **Sonia Vaknin** who is employed there. The legal matter is regarding my father's estate; I am reaching out as I have been very clearly and repeatedly lied to. My father, **Paul Seinen (owner of the Lift Truck Doctor Ltd)**, Passed away on March 23 2025 suddenly and without warning. I was not a witness but was told he simply fell over while he was sitting at a coffee table with his iPad. As far as I am aware, there was no autopsy, but I have also been given limited information. My mother mentioned at some point that there were some interactions with the police regarding the determinations for his death. I was never in contact with the police on this matter however, nor was I informed of anything (from anybody). Not one human being.

When I first approached my mother regarding the will, she lied and said that there wasn't one. I knew this was a lie - Prior to his death, I was aware of the existence of my fathers will. Not only was he a small business owner with a number of investments, but I also have documentation from him and my mother mentioning regular revisions to the document. Clearly lying.

My mother then rescinded this thereafter, said there **was** a will, and said I was to talk to his lawyer contact at HS and Partners, **Sonia Vaknin**. This was an in-person appointment – Sonia sat there and pushed a paper copy of a will from 1995 across the table at me and told me it was current. She said they froze the estate before his death and my brother would be given the company as it was today, and I would get nothing. Basically, that was the entire conversation.

I did not receive a copy of any paperwork, or any additional information about how to move forward. At the time I was escaping an abusive relationship wherein my mother was maintaining communication with my abuser. The story has gone public; I spent the last year of my life putting together a structure by which we can measure emotional abuse in the court system; this initiative is currently trying to get investment. Now that the bulk of the work is completed for my project, I am now following up on loose ends. **Please check out Executivedysfunction.ca see journal notes dated April 7<sup>th</sup>, 10<sup>th</sup> and 11<sup>th</sup>.**

While I have not yet secured a lawyer to do some research into what has occurred, I was able to inquire as to whether there was a court proceeding to name my mother trustee, and there was no such motion completed in Ontario. I believe this means that I was required to give my approval, and I did no such thing.
