

Statement – Conflict re: Paul Seinens' Estate (September 17th 1955 – March 23rd 2025)

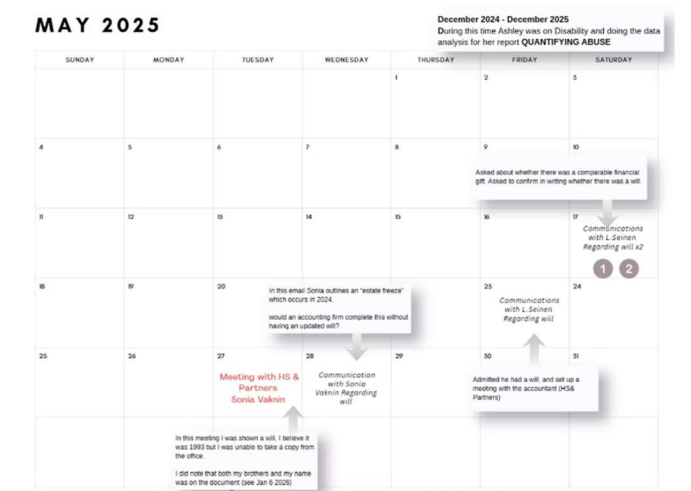
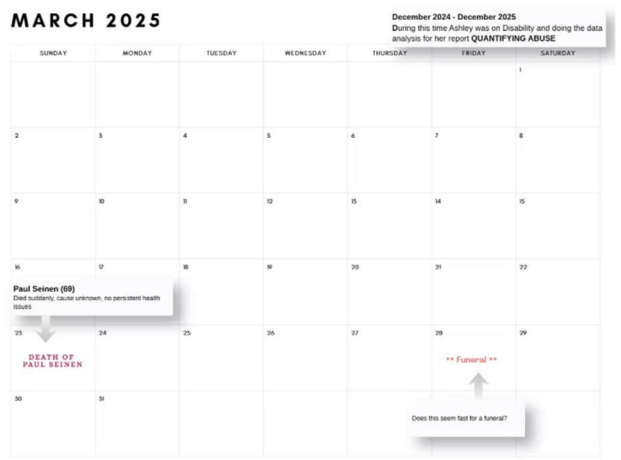
My father died on March 23rd 2025. At the time I was just coming of a very challenging post-separation period and had just received the funding from the marital home. I was spoiling myself a little after a very challenging time. I took My daughter on vacation, and I had gone to Peru to do my 200hr yoga training.

This was after a long period of carrying close to 150K in debt due to a house build during my marriage. My father wanted to help, but my mother prefers to watch me suffer so I signed off on my separation agreement without legal help.

My father passed, the funeral was 4 days later (I question the speed of this). I never had a chance to ask whether there was any investigation as to why. Or how.

I wasn't involved in the planning. I wasn't offered a chance to speak. I had nothing to do with the proceedings; I had nothing but a date and a time. This was not surprising, this was how I was always treated. I didn't even think about the will. I'd just lost my dad. I spent the next month in grief. Also alone.

During this time I was deep in the data for the report. This took an immense amount of time to get the 255k of words from the multiple sources into a consumable format. The concept of Quantifying Abuse is to turn the concept into an app so that this step can be automated.



Nearing the end of April (I don't remember the date (during this time I was looking for a place to move) and I was called to meet with my mother for lunch. I remember noting specifically that she couldn't even look me in the eye. She told me that there was no will, and that my brother (Adam) was getting the company. And she told me that she was willing to pay for my rent for a year to help me out. I asked about insurance and stuff, my father was very formal when it came to this kind of paperwork which is another reason I know the will is not from 1994. That's just not even remotely rational.

The emails that followed these conversations are linked within the calendar online and can be accessed there.

So first I got in touch to let her know that the proceedings would not have worked that way had there been no will (as the estate would have been separated evenly). She then came back and said that there was a will; and had me set up this appointment with Sonia Vaknin at HS and partners.

I met with Sonia, she told me that the business side of the estate was frozen in 2024. She then showed me a document that was dated (I remember 1993/95) it doesn't matter, anytime in the 90's is outlandish).

I remember 2 things about the document. I remember reading Adams (Brother) and my names (I was looking for the kids as I remember the document having a stamp on it. That's it.

As I was in financial difficulty at the time I asked if I had any access to the trust and that was a hard no; that was the whole conversation. I sent a follow up note to Sonia to clarify what she was saying in writing, and her response is also linked in the calendar.

One of the features of the calendar is that I have put in the IP addresses that have accessed my tik tok account (the tik tok report is linked:

I am awaiting the cooperation of the DRPS (Durham Regional Police Department) regarding additional IP data (Wealthsimple report). Which will be added to this calendar when available.

My tik tok account was illegally accessed from Ips both in my area and throughout the GTA. This calendar does not include all of these, but some **wherein the data “stuck out”**.

There was only one from my home town Caledon East. It was only accessed over one weekend only in June of 2025 – directly following the incident with the wills in May. This means that someone at that house illegally accessed my account over one centralized weekend suggesting it was a weekend visit.

Now my daughter told me at one point that she had seen her Oma with dad at some point and believe this may have been my ex illegally accessing my account while visiting her.

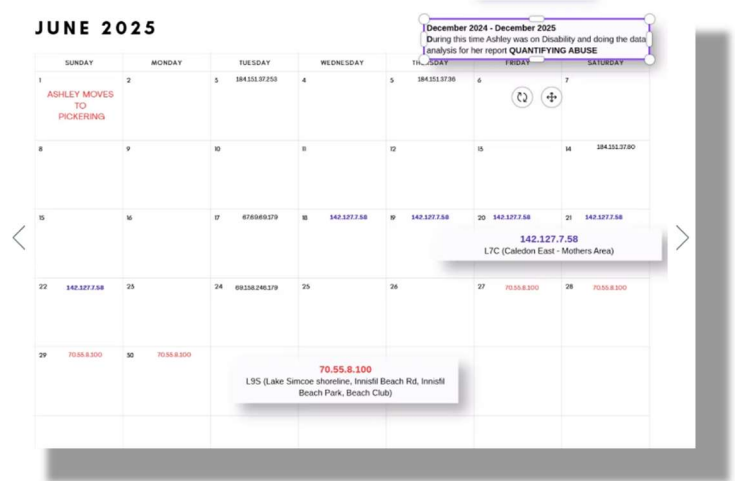
Questions regarding this interaction:

1. Who accessed the account? Mother? or was someone else on the property at this time?
2. What kind of finances were exchanged at that interaction?
3. **Is this enough to get a subpoena for this information?**
4. The next week this account was accessed near lake Simcoe for a week – can this be correlated with someones' movements?

Throughout the fall I had to sideline this issue; as I mentioned in previous videos, I considered and still consider Quantifying Abuse to be more important. Quantifying Abuse was the thing that was going to help others; hopefully save some kids from the anarchy of the court system so my energy went there; I parked the inheritance issue entirely and went head down into my report.

Now during this time in my community there is a bunch of soft evidence. For the purposes of this case, I'd like to keep it to data. First off there is a huge population in the community who have basically told to avoid me like I have the plague. People literally will turn heel when they see me and go the other way. I have still not confirmed what has been said about me to make them do that.

In addition, there was two incidences of triangulation in my new environment. One was a group of men aged 20-40 (approx.) and my ex, in the sporting community. And the other was some dog walkers and my mom. There are notes about these issues/incidences within the subtext in the video series. **Now this is soft evidence and I have more, but honestly I'd rather not use it.** The IP data should be enough to get warrant for more information that may be more telling.



Triangulated messaging I got through the neighbours (and this is soft evidence at this point, I have simply experienced this so often I recognize the shift in tone and verbiage) regarding the will was: “this isn’t important”, and “its always the other spouse”, and “when are you going back to work”.

“Stop talking about the will. Stop the project. Get back to work.”

This messaging escalated via these individuals throughout the fall. To the point where they were straightup asking “when are you going back to work”. I started getting indicators that they were tracking my behaviour. I am unsure as to when the group of neighbours talking to my mother started colluding with the group communicating with my ex, but this occurred at some point as well.

I did not stop - I worked like a dog the whole 5 months on the report and finally got it done and out on my birthday (December 20th 2025). This is when I started the video series wherein I started talking about the report and generational trauma.

On January 6th there is an affidavit signed about the will (I didn’t now this until afterwards). This occurred before I started talking about my inheritance, and before I lodged a complaint with the Law Society of Ontario (LSO).

My mother had an affidavit signed off on two days after the holiday break (after I started speaking about my domestic abuse case which she was openly discussing with my neighbours prior to this). **This looks to be a retaliation.** This was pre-meditated before the holidays (there is no way they could have put this together in two days). Which means that my mother had this in hand before the holidays.

Following this the procession of events is detailed in videos – recorded almost one per day (and they’re averaging 6-9min/each). This is recorded in the calendar online. This included a number of videos wherein I discussed my fathers will and the law firm that has lied (HS&Partners). I got one additional communication from them wherein S. Vaknin threatened with libel and slander, noting that HS&Partners had nothing to do with the writing of the will. This communication is also linked into the calendar.

The procession of scams that occurred in my life are detailed in the calendar and color coded throughout the spring to summer 2026. Documents regarding these are also available on the website. Theres a bunch of clues to be tied together.

I’ve already gone through the mass of scams which are all detailed in videos, and documents. In addition to the people in the RCMP scam knowing things about my personal finances (that only someone close to me would know); the RCMP scam is 100% something personal. There was also escalation within this procession of events which **is aligned with personal timelines in my life.** Again, this indicates that this is an attack from someone with a personal connection to me.

Now by the soft evidence I know that there are a whole bunch of people in my area who have basically been weaponized in this case. I have this in the soft evidence, but as mentioned the IP data should be sufficient in this case.

In the summer I secured a lawyer and we began the proceedings of getting in contact with the estate trustee. This is when was provided the documentation for the affidavit that was drawn up about the will on January 6th. The will that was attached to the affidavit was not the same as the one that was shown to me at the meeting with HS&Partners.

On August 28th I sent the communication below Barry Fish (who authored the affidavit) regarding the issues with the document.

Good Morning Barry and thanks for the quick response.

I understand that you don't want to be involved and honestly neither do I, but the fact remains that this is a component of a large harassment campaign that has been lodged on my life. This is no longer and Estate concern. This is a criminal concern as well. My mother has organized an attempt on my life which is just..... something.

I have no shame in these things - I have been hurt that badly. And I will not go quietly into the night. You are welcome to watch the whole story from the beginning: its all been recorded in videos - which I am now understanding is more valuable than I intended. PLEASE WATCH: [War of the Apes - Timeline | Executive Dysfunction](#). From the beginning - so you know why I'm being so loud.

In the interim - I have questions about these legal documents (for the record, and you don't have to respond.....). And these are for all and I will also be posting these publicly and on the website. So you can all follow along on these messiness. It's a wild ride, so I'm sure you won't get bored.

General Comment: The concept that my fathers will was from anytime in the 90's is absolutely ridiculous. Not only did he have a business and substantial investments (none which I currently have any information about whatsoever as I have been left out of the financial proceedings entirely), but he also informed me regarding my inheritance (the house, Adam got the business) and informed me it changed every time there was a grandchild born. As I said the concept is ridiculous. You have all been manipulated by a women with mental health problems.

1. My fathers accounting firm (HS&Partners, now added to this groupchat) made a substantial change to **freeze the estate in 2004**, at this time I was in extreme financial abuse in my post-separation period and my parents were debating whether to help me. Making a change to an estate during this time is - interesting. I know this would have been something my mother wanted and not my father. He then died 6 months later suddenly without cause at the age of 69. Does this not raise alarm bells for people? The woman I had concocted in my head growing up could have never done what my mother has done to my life in this community (she has paid people to harass me) - I did not know her. I don't know what she is capable of.
 - a. **Would the estate freeze in 2004 not have caused an update to the will?** This seems insane to me.
2. The document I was shown by S. Vaknin on May 28th was a stamped document (which I assumed meant it was notarized (I'm not in the legal field (and thank god what a mess))), it also had the names of the beneficiaries (my brother and I) on the document. The will I received attached to this affidavit **did not have our names on it**. Was this the reason behind the "draft" being required to be notarized?

I have attached the communications related to this case between me and my mother and me and Ms Vaknin for reference.

The fact that know that decisions have been made here based on who you thought would win, and not your ethics is exactly why I'm speaking and will not shut up no matter what happens. So understand that. What has happened in this case is an atrocity.
